Tyrrell Seed Orchard Maintenance Projects

Background

The Eugene BLM District, for several years, has participated in the yearly National Public Lands Day event. On September 18, 2004, the BLM Tyrrell Seed Orchard will be one of the sites for participation.

Proposed Action

During this event several projects are scheduled for implementation which would include the following:

- perform trail maintenance on the Succession Forest Trail (brushing, pulling or clipping vegetation, trash removal, and leveling trail where needed.
- clean out existing bird boxes.
- construct and install cedar log benches at the arboretum overlook area.
- construct large bird and/or bat boxes from pre cut materials and install them.

Decision

It is my decision to approve the Proposed Action to permit maintenance as described above at the Tyrrell Seed Orchard.

Rationale

The Proposed Action qualifies as a categorical exclusion as described in the National Environmental Policy Act Handbook H-1790, Appendixes, Part A - Departmental Categorical Exclusions (516 DM 2, Appendix 1), number 1.7 which states, "Routine and continuing government business, including such things as . . . maintenance and replacement activities having limited context and intensity, e.g., limited size and magnitude or short term effects" and, 516 DM 6, Appendix 5, 5.4, Section A. Fish and Wildlife (3) which states, "Construction of perches, nesting platforms, islands and similar structures for wildlife use." The Proposed Action does not meet any of the exception criteria and therefore an Environmental Assessment (EA) is not necessary.
